

## Team Summit Mt. Hood 2023 Summer Training Camp

Where: Timberline Lodge, Oregon <https://www.timberlinelodge.com>

When: July 28 – August 6, 2023

Coaches: Jared and additional Team Summit Alpine Coaches

Who: All 2023-24 registered Team Summit Alpine U14, U12 Ability and Age Class Athletes (U10 with coach approval), Non-Members may be accepted on a space available basis – contact [jared@teamsummit.org](mailto:jared@teamsummit.org) with inquiries.

Included: 8 days of SL and GS training, accommodations, transportation and meals (Travel days and day off activities and meals are an individual responsibility).

**Member Cost: \$2995**

**Non-Member Cost: \$3495**

\*Non-member price is available to limited pre-approved athletes not currently registered for a Team Summit 2023-24 program.

Deposit: \$250 deposit required with registration

Balance due: Fee must be paid in full by July 15, 2023

Registered athletes may travel from and return to Summit County in the van with coaches. Athletes traveling by air may send ski bags and limited additional bags in van.

### Details:

Timberline Lodge and the Palmer Snowfield have been a host to summer ski training camps for clubs, academies and the US Ski Team for more than five decades. July and August normally provide the highest quality training with consistently good weather, overnight freezes and less crowding. This year's snowpack is substantial and ensures sufficient snow for the entire summer.

Athletes will stay in coach chaperoned rental homes in Welches with proximity to off-snow activities. All meals will be "family style" with athletes having the opportunity to help with meal planning, preparation and clean-up on a rotating basis.

### Schedule:

July 27 Vans depart Summit County Early AM. Camping overnight en route.

July 28 Van Arrival at lodging in Welches – Families not participating in van travel, please plan arrival between 12-6 PM.

July 29-Aug1 Training

- Aug 2 Day Off (Planned activities TBD – activity costs and day off meals are an individual responsibility)
- Aug 3-6 Training
- Aug 6 Van Departure from Timberline after training at 11AM. Camping overnight en route.
- Aug 7 Van Returns to Summit County (Time TBD)

Any withdrawal from camp for injury or health reasons will receive a pro-rated refund of recoverable camp fees.

*All participants must complete a Timberline waiver in addition to Team Summit Waiver (Athletes registered for a Team Summit Colorado 2023-24 program do not need to complete an additional TSC waiver)*
