# 2022 MESSAGE

Welcome to Team Summit Colorado.

We are a youth development organization empowering our athletes to realize and celebrate their personal podiums through athletics, education, and life skills. Our athletes begin with a foundation of family and fun and progressively work to the excellence that defines Team Summit as a premier environment for their development.

The 2021-22 season saw Team Summit capitalize on the momentum generated from the previous season and achieve a new all-time record of 656 athletes. While all of our programs were successful, our introductory level programs saw significant growth resulting in the creation of a dedicated Program Director position within our leadership team. We created new offerings to accommodate the rising demand while maintaining quality coaching which almost immediately sold out for the season. We saw 2 athletes compete in the Junior World Championships and once again two of our athletes were named to the US Ski Team. Team Summit had more elite level competitors and national champions than at any time in the history of the organization. Our Alpine program was recognized for having the 3rd most elite athletes in the US Ski Team Development pipeline and that contributed to Team Summit being named Alpine Club of the Year by US Ski and Snowboard Association.



Our long term relationships with our donors and other strategic partners have fostered strong partnerships reinforcing our culture of community outreach and fundraising efforts. We appreciate the generous support of all of our sponsors at every level. This year we entered into a partnership with the Paul Kresge Memorial Fund to advance Summit County scholarship opportunities as a component of our overall scholarship awards process.

We also created the Rosener Human Performance Center at Copper Mountain offering our athletes a multidisciplinary indoor training venue in close proximity to our on-snow venue at the base of the mountain. This venue allows our athletes to train in a safe and controlled environment with access to multiple options for strength and conditioning equipment and training protocols adjacent to our Copper Mountain venues.

The Team continues in a strong financial position and through the strength of our business relationships and the efficiency of our operations we have been able to fully fund our capital reserve targets which invests in the long term financial stability of the Team.

We continue to advance our culture as we Elevate Youth through our vision of whole athlete, whole team, whole community.

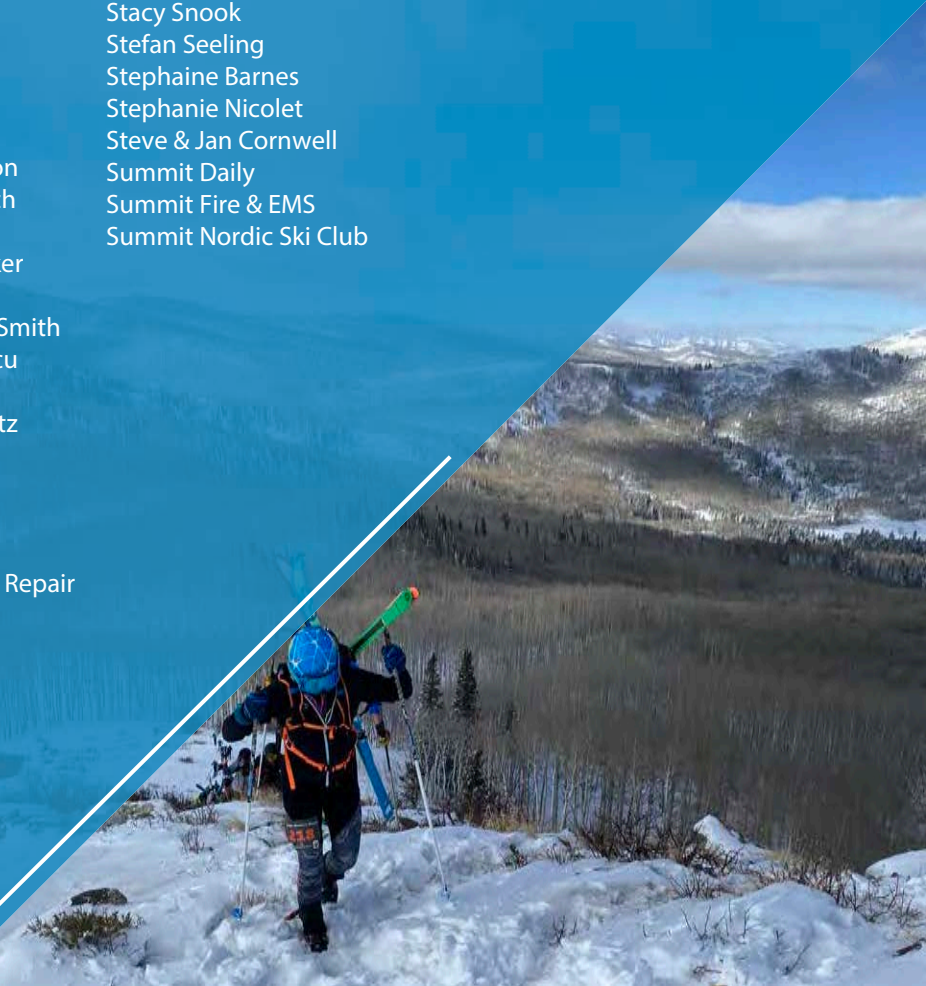
